

# MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Investment Objectives and Strategies

The fundamental objective of the Sun Life NWQ Flexible Income Fund (the "Fund") is to seek to achieve income and capital appreciation by investing primarily in a diversified portfolio of income producing securities.

The Fund's sub-advisor is NWQ Investment Management Company, LLC. (the "sub-advisor"). The Fund's investment strategy is to invest in a wide range of income producing securities of issuers, including but not limited to: preferred securities, corporate debt, mortgage-backed securities, taxable municipals and government and agency debt securities. The sub-advisor seeks to employ a rigorous, bottom-up research concentrated investment process that focuses on financial statement and absolute valuation analysis to identify undervalued companies that offer favourable risk/reward characteristics and capital preservation. Given this investment process, the sub-advisor may invest anywhere in the world but may have a tendency to have a high geographic concentration to the U.S.

### Risk

There were no changes in the Fund's investment objective or strategy during the period which materially impacted the overall level of risk in the Fund. The risks associated with investing in the Fund remain as outlined in the Fund's Simplified Prospectus.

## **Results of Operations**

During the period, the net asset value of the Fund increased from \$48.7 million to \$68.8 million. The increase in net asset value was due to positive net sales, partially offset by negative performance in the period.

During the period, the Fund returned -1.4% for Series A units. This result trailed the Fund's benchmark, the Barclays U.S. Aggregate Bond C\$ Hedged Index, which returned 1.1%. The performance returns for other series of this Fund are similar to those of Series A except for differences in expense structures. Please refer to the 'Past Performance' section of this report for performance of each series.

A number of holdings in the Telecommunications industry were under pressure for the year, including Centurylink and Frontier senior debt and convertible preferred shares. These positions weakened noticeably during the second half of 2015 when a re-pricing occurred within the industry given the slowdown of new debt supply and an overall negative sentiment in high yield. These holdings, however, have the largest revenue bases and market capitalizations, with improving or stable credit metrics. The sub-advisor views these setbacks as temporary and believes these holdings will revert to trading to their true fundamentals in the near to intermediate term.

Caterpillar ("CAT") common stock was a detractor for the year. Over half of CAT's sales are international, and one quarter of sales are in the particularly vulnerable markets of Asia and Latin America. Weakness in construction and mining equipment sales are expected to be weak for the intermediate term and the sub-advisor believed its valuation did not fully incorporate the significantly weaker global economic backdrop that developed. The sub-advisor eliminated the position in the third quarter.

National Storage ("NSA") common stock was the top contributor for the year with a 37% return. NSA is a selfstorage REIT that has been underperforming its peers since its initial public offering ("IPO") in April. Their first earnings release since the IPO was significantly better than expected and they also increased their dividend.

Despite the oil rout, some of the direct energy holdings stood out as top performers for the year, including Memorial Production Partners 7 5/8% 5/1/21 and Vanguard Natural Resources 7 7/8% 4/1/20. These positions were exited during the first half of the year as the sub-advisor believed these master limited partnership bonds were trading at too high a valuation given the price of oil.

## **Recent Developments**

The U.S. Federal Reserve (the "Fed"), China, the U.S. Dollar, and commodities are expected to continue to be the interconnected common catalysts affecting risk assets in

2016. With recent credit spread widening, the sub-advisor sees many opportunities in both the investment grade and high yield markets and believes as long as the Fed keeps a steady and moderate pace in future rate hikes, the impact on the fixed income market will be minimal. Credit spreads are expected to tighten from current levels and the rate curve is expected to flatten (lower rates in longer maturities and higher rates in the shorter maturities). Equities will be a true test of security selection as many stocks have reached record valuations. If economic growth in 2016 weakens, investors may find it difficult to justify higher multiples on certain companies. Preferred shares have experienced two straight years of impressive performance, avoiding most of the volatility that was experienced in other asset classes. Nevertheless, the sub-advisor still sees pockets of opportunities and value in some preferred shares.

## **Related Party Transactions**

Sun Life Global Investments (Canada) Inc. (the "Manager") is the manager, trustee and portfolio manager of the Fund.

The Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

As trustee, the Manager holds legal title to the Fund's investments in trust for unitholders. For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisors. The Manager has retained NWQ Investment Management Company, LLC to act as a subadvisor for the Fund.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc.

## Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the "Administration Expenses") in return for a fixed administration fee paid to the Manager by each Fund ("Administration Fee"). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees (including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund's Statement of Comprehensive Income found in the annual financial statements (audited).

Each Fund also pays certain operating expenses directly (the "Fund Costs"). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund's Independent Review Committee ("IRC"); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of units. The Fund Costs that are specific to a series of units are allocated to that series. These amounts are paid out of the assets attributed to each series of units of the Fund, which reduces the return you may receive.

## Series Description

The Fund offers the following series of units: A, E, F, I and O. The date of creation for the Series A, F, and I units was February 3, 2014 and the date of creation for Series E and O units was April 1, 2014.

Series A units are available to all investors.

Series E units are available to investors through the Private Client program and must be purchased through a Private Client account. Investors in Series E units are eligible for management fee reductions, if any, based on the value of Series E units held in their Private Client account. Any management fee reduction will be paid to investors as a fee distribution by the Fund, which will be reinvested in additional Series E units. As announced on December 15, 2015, in connection with changes to the Private Client Program, all Series E units will be re-designated as Series A units on February 5, 2016. Please refer to the Fund's simplified prospectus for more details about the captioned change and for details about the Private Client Program.

Series F units are available to investors who have a fee-based account with their dealer and whose dealer has signed an agreement with the Manager. Instead of paying sales charges, investors buying Series F units pay fees to their dealer for investment advice and other services. The Manager does not pay any commissions to dealers in respect of Series F units, so the Manager can charge a lower management fee.

Series I units are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I units are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

Series O units are available to investors through the Private Client program and must be purchased through a Private Client account. Each Series O investor pays a management fee directly to the Manager and is eligible for management fee reductions, if any, based on the value of Series O units held in the investor's Private Client account. Series O management fees are paid, after subtracting any management fee reductions, by a redemption of Series O units in the investor's account.

The higher a Fund's portfolio turnover ratio in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund.

### Management Fees

The annual maximum management fee paid by the Fund is a percentage of the average daily net asset value of each series exclusive of any applicable taxes and operating expenses, which is accrued daily and is paid to the Manager monthly in arrears. Management fees pay for portfolio and investment advisory services, oversight of any service providers, marketing and promotional activities, arranging for the distribution and sale of securities of the Fund, general administration of fund operations and sales and trailing commissions paid to dealers.






#### Year-by-Year Returns


## Series A Units – Annual return for the periods ended December 31, 2015









## Series F Units – Annual return for the periods ended December 31, 2015
