MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

During the period, the net asset value of the Sun Life Franklin Bissett Canadian Equity Class (the "Fund") increased from \$4.2 million to \$6.4 million. The increase in net asset value was due to positive net sales, as well as positive performance during the period.

During the period, the Fund returned 1.1% for Series A shares. This result surpassed the Fund's benchmark, the S&P/TSX Composite Index, which returned 0.7%. The performance returns for other series of this Fund are similar to those of Series A except for differences in expense structures. Please refer to the 'Past Performance' section of this report for performance of each series.

The Fund currently invests substantially all of its holdings in units of the Franklin Bissett Canadian Equity (the "underlying Trust Fund"). The following commentary relates to the underlying Trust Fund.

The underlying Trust Fund benefitted from security selection and interaction effects driven by individual holdings in the Consumer Discretionary and Materials sectors. This advance was partially offset by underperforming holdings in the Energy and Consumer Staples sectors. Positive sector allocation also helped, with gains realized from the Fund's overweight positions in the outperforming Industrials and Consumer Discretionary sectors.

The underlying Trust Fund is overweight in the Consumer Staples sector, and underweight in the Materials and Energy sectors.

Trading activity remained steady during the period as ongoing volatility presented a number of attractive rebalancing opportunities. There were five new additions and six eliminations during the period.

Recent Developments

Though the broad Canadian equity market showed some weakness in the second quarter of 2017, Franklin Bissett Investment Management (the "sub-advisor") continues to be less optimistic for future return potential, given the view of a general reduction in compelling investment opportunities.

While the sub-advisor still believes the Canadian equity market offers the potential for multi-year returns close to long-term trend annualized returns in the mid- to high single-digit range, the likelihood of less favourable returns remains elevated.

Effective February 5, 2016, all Series E shares were converted to Series A shares, under the Front End Sales Charge option, of the same Fund. Please refer to the Fund's simplified prospectus for more details about the captioned change and for details about the Private Client Program.

Related Party Transactions

Sun Life Global Investments (Canada) Inc. (the "Manager") is the manager and portfolio manager of the Fund.

The Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisors. The Manager has retained Franklin Bissett Investment Management, part of Franklin Templeton Investments Corp. to act as a sub-advisor for the Fund.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc.

Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the "Administration Expenses") in return for a fixed administration fee paid to the Manager by each Fund ("Administration Fee"). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees

(including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund's Statement of Comprehensive Income found in the semi-annual financial statements (unaudited).

Each Fund also pays certain operating expenses directly (the "Fund Costs"). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund's Independent Review Committee ("IRC"); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of shares. The Fund Costs that are specific to a series of shares are allocated to that series. These amounts are paid out of the assets attributed to each series of shares of the Fund, which reduces the return you may receive.

Series Description

The Fund offers the following series of shares: A, AT5, F, I and O. The date of creation for all series was March 27, 2015.

Series A and AT5 shares are available to all investors.

Series AT5 shares are designed to provide investors with a fixed monthly cash distribution based upon a target annualized distribution rate of 5% of the net asset value per share as at the end of the prior year.

Series F shares are available to investors who have a fee-based account with their dealer and whose dealer has signed an agreement with the Manager. Instead of paying sales charges, investors buying Series F shares pay fees to their dealer for investment advice and other services. The Manager does not pay any commissions to dealers in respect of Series F shares, so the Manager can charge a lower management fee.

Series I shares are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I shares are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

Series O shares are available to investors through the Private Client program and must be purchased through a Private Client account. Each Series O investor pays a management fee directly to the Manager and is eligible for management fee reductions, if any, based on the value of Series O shares held in the investor's Private Client account. Series O management fee is paid, after subtracting any management fee reductions, by a redemption of Series O shares in the investor's account.

Management Fees

The annual maximum management fee paid by the Fund is a percentage of the average daily net asset value of each series exclusive of any applicable taxes and operating expenses, which is accrued daily and is paid to the Manager monthly in arrears. Management fees pay for portfolio and investment advisory services, oversight of any service providers, marketing and promotional activities, arranging for the distribution and sale of securities of the Fund, general administration of fund operations and sales and trailing commissions paid to dealers.

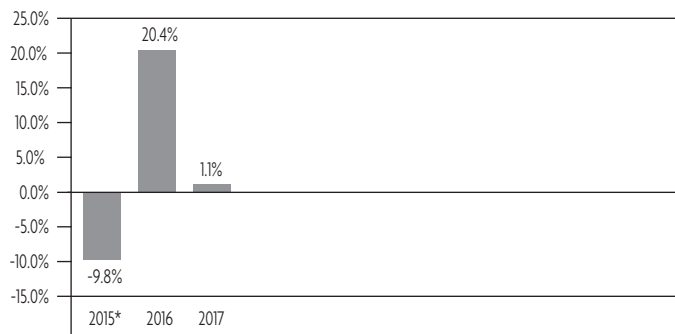

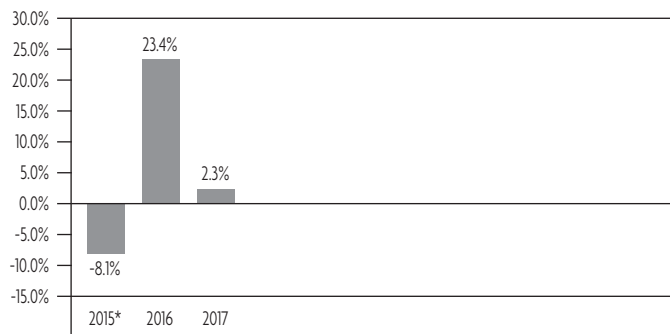

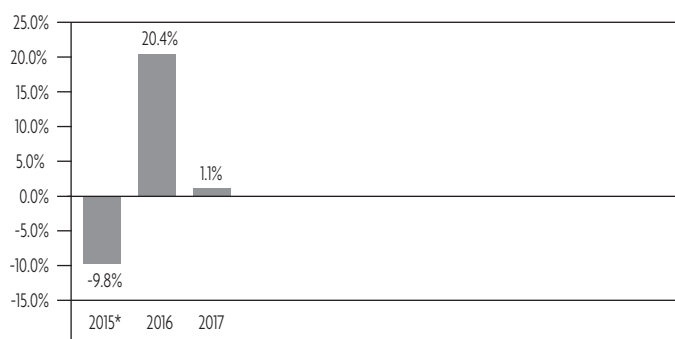
Series A Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017



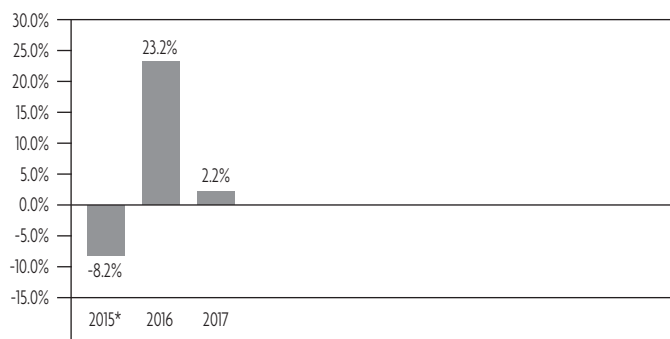
Series I Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017



Series AT5 Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017

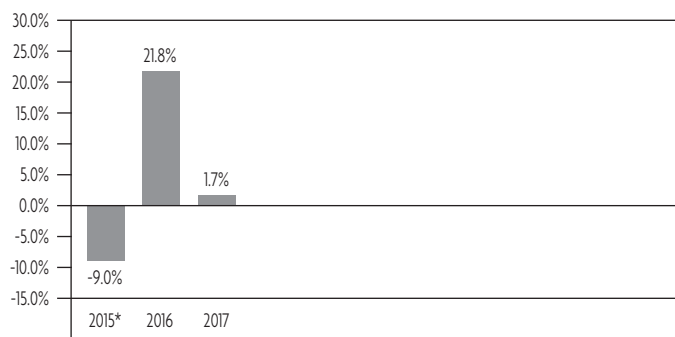


Series O Shares – Annual return for the period ended December 31 and the six month period ended June 30, 2017
