MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

During the period, the net asset value of the Sun Life MFS U.S. Growth Fund (the "Fund") decreased from \$713.0 million to \$568.4 million. The decrease in net asset value was attributable to net outflows caused by an institutional level re-balancing, partially offset by positive performance during the period.

During the period, the Fund returned 12.3% for Series A units. This result surpassed the Fund's benchmark, the Russell 1000 C\$, which returned 5.8%. The performance returns for other series of this Fund are similar to those of Series A except for differences in expense structures. Please refer to the 'Past Performance' section of this report for performance of each series.

Security selection and an overweight position in the strong-performing Information Technology sector lifted performance relative to the benchmark. Within this sector, the Fund's overweight position in software company Adobe Systems, video game makers Activision Blizzard and Electronic Arts, and social media company Facebook boosted relative returns. Not holding shares of diversified technology products and services company IBM also helped relative results as shares of IBM lagged the benchmark during the period.

Stock selection and an underweight position in the Consumer Staples sector also added to relative returns. However, there were no individual stocks within this sector that were among the top relative contributors for the reporting period.

Strong security selection in the Real Estate sector further supported relative results. The Fund's overweight position in broadcast and communications tower management firm American Tower helped relative performance within this sector.

Stocks in other sectors that aided relative performance included not holding shares of telecommunications company Verizon Wireless and media conglomerate Walt Disney and overweighting shares of internet retailer Amazon.com and paint and coating manufacturer Sherwin-Williams.

Weak stock selection in the Financials sector hurt relative performance. However, there were no individual stocks

within the Financials sector that were among the top relative detractors for the reporting period.

The Fund's overweight position and stock selection within the poor-performing Energy sector also dampened relative results. Within this sector, holding shares of independent oil and gas exploration and production company Pioneer Natural Resources weighed on relative returns.

Elsewhere, the Fund's underweight position in computer and personal electronics maker Apple and overweight positions in apparel retailer Ross Stores, farm and ranch product retailer Tractor Supply Company, discount variety store operator Dollar Tree, basic materials producer Vulcan Materials and global fleet vehicle fuel card provider Fleetcor Technologies hindered relative performance. Not holding shares of aerospace company Boeing and fast-food company giant McDonald's also weakened results as the stocks of both companies outpaced the benchmark.

The Fund's cash and/or cash equivalents position during the period was also a detractor to relative performance. Under normal market conditions, the Fund strives to be fully invested and generally holds cash to buy new holdings and to provide liquidity. In a period when equity markets rose, as measured by the Fund's benchmark, holding cash held back performance versus the benchmark, which has no cash position.

Recent Developments

For the first time in many years, markets are experiencing synchronized global economic growth. The rebound in Emerging Markets ("EM") economies has been more pronounced (despite the deceleration in Chinese growth at the end of the period), helped by some larger economies (i.e., Brazil and Russia) emerging from recessions. At the same time, Developed Market ("DM") economies continued to grow at or above potential. Market confidence increased in the U.S. after the presidential election in November in anticipation of lower taxes, a lighter regulatory burden and increased infrastructure spending, boosting U.S. equities and corporate bond performance. While global inflation faded during the period as commodity prices, particularly oil, leveled off or declined, global growth remained relatively resilient. As a result, there have been more tightening signals and actions by DM central banks. The U.S. Federal Reserve increased

interest rates by 0.25% at the end of the period, bringing the total number of 0.25% hikes in the Federal Funds rate to four since December 2015. The European Central Bank (“ECB”) appears set on announcing Quantitative Easing tapering in the fall of 2017. The Bank of England may also begin reducing monetary accommodation. Markets have been comforted (along with central banks) by the decline in fears of a populist wave in Europe after establishment candidates won the Dutch and French elections. European growth has reflected the more constructive political economic backdrop.

The headwind of a stronger U.S. dollar faded during the period while U.S. consumer spending held up well amid a modest increase in real wages and relatively low gasoline prices. Demand for automobiles tapered off from near-record territory at the end of the period, while the housing market continued its recovery amid relatively low mortgage rates and tight inventories. Global trade, which was sluggish early in the period, showed signs of improvement, a positive indicator of global economic activity and prospects. Receding fears that President Trump would follow through on various campaign threats and promises that were judged to be detrimental to EM, helped EM resume their upward trajectory, powered by strong inflows throughout the first half of 2017.

Effective February 5, 2016, all Series E and EF units were re-designated to Series A units, under the Front End Sales Charge option, and Series F units, respectively, of the same Fund. Please refer to the Fund’s simplified prospectus for more details about the captioned change and for details about the Private Client Program.

Related Party Transactions

Sun Life Global Investments (Canada) Inc. (the “Manager”) is the manager, trustee and portfolio manager of the Fund.

The Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

As trustee, the Manager holds legal title to the Fund’s investments in trust for unitholders. For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisors. The Manager has retained MFS Institutional Advisors, Inc. (“MFS”), an affiliate, to act as a sub-advisor for the Fund.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc., which also has an indirect majority ownership interest in MFS.

Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the “Administration Expenses”) in return for a fixed administration fee paid to the Manager by each Fund (“Administration Fee”). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees (including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund’s Statement of Comprehensive Income found in the semi-annual financial statements (unaudited).

Each Fund also pays certain operating expenses directly (the “Fund Costs”). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund’s Independent Review Committee (“IRC”); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of units. The Fund Costs that are specific to a series of units are allocated to that series. These amounts are paid out of the assets attributed to each series of units of the Fund, which reduces the return you may receive.

Series Description

The Fund offers the following series of units: A, AH, T5, T8, F, FH, I, IH, O and OH. The date of creation for Series A, F, and I units was October 1, 2010, the date of creation for Series AH was February 1, 2011, the date of creation for Series T5 and T8 units was September 1, 2011, the date of creation for Series O units was April 1, 2014, and the date of creation for Series FH, IH and OH units was July 29, 2016.

Series A, AH, T5 and T8 units are available to all investors.

Series T5 and T8 units are designed to provide investors with a fixed monthly distribution based on a target annualized distribution rate of 5% and 8%, respectively, of the net asset value per unit of the relevant series at the end of the prior year.

Series F units are available to investors who have a fee-based account with their dealer and whose dealer has signed an agreement with the Manager. Instead of paying sales charges,

investors buying Series F units pay fees to their dealer for investment advice and other services. The Manager does not pay any commissions to dealers in respect of Series F units, so the Manager can charge a lower management fee.

Series FH units are available to investors who have a fee-based account with their dealer and whose dealer has signed an agreement with us. The characteristics of Series FH units are the same as Series F units, except that the return of Series FH units will reflect the performance of the Fund after hedging substantially all of the foreign currency exposure attributable to Series FH.

Series I units are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I units are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

Series IH securities are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series IH units are not sold to the general public. The characteristics of Series IH units are the same as Series I units, except that the return of Series IH units will reflect the performance of the Fund after hedging substantially all of the foreign currency exposure attributable to Series IH.

Series O units are available to investors through the Private Client program and must be purchased through a Private Client account. Each Series O investor pays a management fee directly to the Manager and is eligible for management fee reductions, if any, based on the value of Series O units held in the investor's Private Client account. Series O management fees are paid, after subtracting any management fee reductions, by a redemption of Series O units in the investor's account.

Series OH units are only available to investors through the Private Client Program. The characteristics of Series OH units are the same as Series O units, except that the return of Series OH units will reflect the performance of the Fund after hedging substantially all of the foreign currency exposure attributable to Series OH.

Management Fees

The annual maximum management fee paid by the Fund is a percentage of the average daily net asset value of each series exclusive of any applicable taxes and operating expenses, which is accrued daily and is paid to the Manager monthly in arrears. Management fees pay for portfolio and investment advisory services, oversight of any service providers, marketing and promotional activities, arranging for the distribution and sale of securities of the Fund, general administration of fund operations and sales and trailing commissions paid to dealers.




Year-by-Year Returns


Series A Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017



Series AH Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017




Series T5 Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017




Series T8 Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017




Series I Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017




Series F Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017




Series IH Units – Annual return for the period ended December 31 and the six month period ended June 30, 2017
