MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The fundamental investment objective of Sun Life BlackRock Canadian Composite Equity Class (the "Fund") is to seek longterm capital appreciation through exposure to primarily equity securities included in a broad and recognized Canadian equity market index that includes primarily large and mid-market capitalization companies the securities of which are considered to the be the most liquid in Canadian equity markets by investing primarily in units of Sun Life BlackRock Canadian Composite Equity Fund or its successor fund (the "underlying Trust Fund").

The underlying Trust Fund's sub-advisor (the "sub-advisor") is BlackRock Asset Management Canada Limited. The subadvisor invests directly in the securities included in the Index and/or may achieve exposure to some or all of the Index by investing in exchange-traded funds, mutual funds or derivatives that are correlated to the performance of the Index. The underlying Trust Fund rebalances on a quarterly basis based on changes to the underlying Index, or more frequently if warranted by market conditions.

Risk

There were no changes in the Fund's investment objective or strategy during the period which materially impacted the overall level of risk in the Fund. The risks associated with investing in the Fund remain as outlined in the Fund's Simplified Prospectus.

Results of Operations

During the period, the net asset value of the Fund increased from \$0.6 million to \$7.6 million. The increase in net asset value was due to positive net sales, as well as positive performance during the period.

During the period, the Fund returned 19.7% for Series A shares. This result lagged the Fund's benchmark, the S&P/TSX Capped Composite, which returned 21.1%. The performance returns for other series of this Fund are similar to those of Series A except for differences in expense structures. Please refer to the 'Past Performance' section of this report for performance of each series.

The following commentary relates to the underlying Trust Fund.

Canadian markets made strong gains in the first half of the period. The S&P/TSX Capped Composite Index was one of the best performing indexes in developed markets. The gains were mostly stable with a few notable drawdowns in early May and a strong recovery. This was followed by weakness in June, although the month made a small bounce in the last week to end positive on a total return basis.

The S&P/TSX Composite Index continued to accelerate its gains in the fourth quarter of the period, adding another 4.5%. The largest contributions came from the Financials and Energy sectors whilst the Materials and Healthcare sectors were the weakest in the quarter. Within the Financials sector, the main drivers of performance came in the last two months as strong earnings numbers drove stocks higher. Within the Energy sector, stocks exhibited fairly large swings within the quarter as macroeconomic drivers had the effect of moving the entire sector throughout the quarter.

Recent Developments

The main macroeconomic driver for the Energy sector was the highly anticipated Organization of the Petroleum Exporting Countries ("OPEC") meetings. Markets were quick to move on any rumour making headlines but in the end, oil production cuts were agreed to, most notably by Saudi Arabia and Russia. Analysts were quick to caution that the U.S. shale producers with the ability to quickly ramp up production could throw a wrench into the mix.

During the fourth quarter, Donald Trump won the U.S. Presidential election, surprising markets and pundits alike. On a platform of increased fiscal spending, tax reforms, and an emphasis on putting U.S. employees first, the so called 'Trump Trade' saw a regime shift take place in the markets with surprising speed. Immediate effects felt in Canada were related to Industrials with exposure to U.S. building projects rising, whilst exporting industries like Forestry falling (due for a potential renegotiation of Canada/U.S. trade agreements). Some of these immediate moves would revert slightly, but market participants overall saw a regime switch and rotation in leadership in the markets. The U.S. Dollar saw large gains. Bond investors were subject to large swings in rates as U.S. Government expectations for rate hikes rose. Effective February 5, 2016, all Series E and EF shares were converted to Series A shares, under the Front End Sales Charge option, and Series F shares, respectively, of the same Fund. Please refer to the Fund's simplified prospectus for more details about the captioned change and for details about the Private Client Program.

Related Party Transactions

Sun Life Global Investments (Canada) Inc. (the "Manager") is the manager and portfolio manager of the Fund.

The Manager is responsible for the provision of all general management and administrative services required by the Fund in its day-to-day operations, including providing or arranging for the provision of investment advice, bookkeeping, recordkeeping and other administrative services for the Fund.

For its services, the Manager receives a management fee that is calculated as a percentage of the average net asset value of the Fund. This fee is calculated daily and payable monthly.

As portfolio manager, the Manager is responsible for managing the investment portfolio of the Fund directly or through sub-advisors.

The Manager is an indirect wholly owned subsidiary of Sun Life Financial Inc.

Fund Administrative Expenses

The Manager pays certain of the operating expenses of each Fund (the "Administration Expenses") in return for a fixed administration fee paid to the Manager by each Fund ("Administration Fee"). The Administration Fee is based on the net asset value of each series of the Fund. The Administration Expenses include, but are not limited to, record keeper fees, accounting, audit and legal fees, bank and interest charges, safekeeping and custodial fees, taxes, administrative and systems costs, costs of reports to investors, prospectuses and other disclosure documents, regulatory filing fees (including those incurred by the Manager) and trustee fees for registered plans. The amount of this charge is disclosed as a fund administrative expense in the Fund's Statement of Comprehensive Income found in the annual financial statements (audited).

Each Fund also pays certain operating expenses directly (the "Fund Costs"). Fund Costs include: borrowing costs incurred by the Fund from time to time; costs in connection with portfolio transactions; fees and expenses payable to or in connection with the Fund's Independent Review Committee ("IRC"); taxes payable by the Fund; and the costs of complying with any new regulatory or legal requirement imposed on the Fund. Each Fund allocates Fund Costs proportionately among its series of shares. The Fund Costs that are specific to a series of shares are allocated to that series. These amounts are paid out of the assets attributed to each series of shares of the Fund, which reduces the return you may receive.

Series Description

The Fund offers the following series of shares: A, AT5, F, I and O. The date of creation for Series A, AT5 and F shares was August 1, 2013, the date of creation for Series O shares was April 1, 2014, and the date of creation for Series I shares was May 1, 2015.

Series A and AT5 shares are available to all investors.

Series AT5 shares are designed to provide investors with a fixed monthly distribution based upon a target annualized distribution rate of 5% of the net asset value per share as at the end of the prior year.

Series F shares are available to investors who have a feebased account with their dealer and whose dealer has signed an agreement with the Manager. Instead of paying sales charges, investors buying Series F shares pay fees to their dealer for investment advice and other services. The Manager does not pay any commissions to dealers in respect of Series F shares, so the Manager can charge a lower management fee.

Series I shares are special purpose securities that are currently only available to other mutual funds and eligible institutional investors. Series I shares are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager.

Series O shares are available to investors through the Private Client program and must be purchased through a Private Client account. Each Series O investor pays a management fee directly to the Manager and is eligible for management fee reductions, if any, based on the value of Series O shares held in the investor's Private Client account. Series O management fee is paid, after subtracting any management fee reductions, by a redemption of Series O shares in the investor's account.

The higher a Fund's portfolio turnover ratio in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund.

Management Fees

The annual maximum management fee paid by the Fund is a percentage of the average daily net asset value of each series exclusive of any applicable taxes and operating expenses, which is accrued daily and is paid to the Manager monthly in arrears. Management fees pay for portfolio and investment advisory services, oversight of any service providers, marketing and promotional activities, arranging for the distribution and sale of securities of the Fund, general administration of fund operations and sales and trailing commissions paid to dealers.


PAST PERFORMANCE


Year-by-Year Returns


Series A Shares – Annual return for the period ended December 31, 2016




Series AT5 Shares – Annual return for the period ended December 31, 2016




Series F Shares – Annual return for the period ended December 31, 2016
